### **Projects/Proposals:**

Kanabec SWCD-proposal for the Snake Board to use some of the general project Snake funds for incentive payments to promote ag. management practices; cover crops & no-till. The Board and CAC discussed the practice timeline and suggested a different timeline (3 out of 5 yrs). The 2021 deadline date would be changed to July 1 for 2021. After the discussion it was decided that the policy would be brought back at a June meeting with revisions for review. 1W1P Update- Deanna shared the updates from the 1W1P Policy Committee. Henry Fischer-Pokegama Lake would like to make sure that flooding is addressed within the 1W1P for the Snake River Watershed.

Jason Weinerman-BWSR-the future options regarding if and how the SRWMB will want to engage with the 1W1P implementation process. The Board and CAC discussed options for structuring the SRWMB and CAC after 1W1P implementation. The SRW and CAC members will discuss with their Boards and groups the structure options and will be discussing this as we go through the 1W1P process. At this time the consensus of those attending felt the Joint Powers Entity (JPE) fit what the Board and CAC are already doing.
