Mille Lacs SWCD Board Meeting – MINUTES

Wednesday, August 11, 2021

Call To Order – Chair Janski called the meeting to order at 6:00 PM

Three board members were unable to attend, so without a quorum this will be an informational meeting only and actionable items will be deferred to the September meeting.

- 2. Approval of Agenda (additions and deletions of new business or committee reports)
 - additions ___

- **3. Open Public Forum -** Board policy limits public forum time for board meeting topics not scheduled within the agenda to 10 minutes, but allows time extension by vote. No public comment.
- 4. Consent Agenda deferred to the September meeting
- 5. Staff Reports/Presentations
 - a. <u>SWCD staff chat Q&A: Lynn Gallice, Shoreland Tech</u> Ms. Gallice gave a presentation on the work she is doing with landowners around Mille Lacs Lake to install enhanced buffers. These are all projects' landowners are doing on their own, with no financial assistance, only technical design and planting plan assistance from the SWCD.
 - b. Administrators report Shaw reported that she will take leave the week of August 16-20. A new county coordinator has been hired and will start the last week in August.

6. District Policy, Planning, Activities, Projects, Grants

a. Work Plan Progress Reports (WPPRs) -

Suggestions were shared to identify how best to use the work plan reports to inform decisions or actions to be taken during monthly board meetings. One idea is to separate the WPPRs. Instead of binding them as a group and reviewing together as an agenda item, separate them per agenda action item. Shaw will test this for the September meeting.

Shaw asked for input on the amount and type of information included in the WPPRs. Board members feel the WPPRs are really good overall. It may be worth exploring if the WPPRs could be formatted in a way to split them into a very concise summary piece, without entirely losing the detail about the program purpose, goals and outcomes. The advantage of a concise summary would be for audiences who are interested but not invested enough to read the full WPPR.

- c. <u>Personnel Committee report</u> Casey Field has submitted a letter of resignation. His last day will be August 27th. The personnel committee met with Casey for an exit interview before the board meeting.
- d. Area3/MASWCD Business
 - i. Award nominations due Sept 17 Shaw briefly described the four MASWCD competitive awards and the one non-competitive award options. Shaw recommended the board consider the local chapter National Wild Turkey Federation Rum River Longbeards for the non-competitive Outstanding Conservationist award. The Longbeards committee is an active supported of outdoor sport activities like archery and shooting sports with Milaca school. Many of the members individually participate in forestry, tree planting, conservation planting and RIM easement management. Additionally, the group has expressed interest in submitting a proposal to the SWCD for the nomination. Shaw will work with the Longbeards committee to prepare a nomination proposal for the September meeting.

7. Financials

- a. <u>Statement Audit</u> (Finance Committee Member) LaSalle reconciled the bank statement with the Quickbooks accounting system August 5th.
- b. <u>Annual financial audit for year end 2020</u> Shaw reported the CPA firm Peterson's Company LLC did an inoffice audit July 2th. The district should expect the audit to be finalized late September.
- c. <u>Treasurers Report</u> Shaw reported that time tracking is up to date per grant. Receivables and expenditures are up to date in the program log and QuickBooks. The Wahkon grant will be audited by BWSR in the next few weeks. Shaw plans to engage assistance from Benton SWCD for financial assistance starting late August.
