This project is located on Fish Lake and involves the removal of an existing failing retaining wall and vegetation plantings. The engineers estimated cost \$19,408.68 with fund request of \$13,056.51.

**CAC Recommendation:** A motion was made by Kevin Belkholm, seconded by Kathy Nielson to recommend to approve up to 75% of the lowest bid received with a maximum funding of the requested \$13,056.51.
